Before registering for our 2024 Lake Powell Sober Adventure, there are a few things we want you to know about attending this event.

Our goal is to provide a fun, safe, and supportive environment for everyone involved. Any behavior deemed offensive or harmful to others will not be tolerated and may result in expulsion from this and future events hosted by the Rule 62 Foundation. In some cases, legal action will be taken if warranted.

While this is a free trip with food, beverage, water transportation and activities provided, **you will be responsible for**:

Transportation to and from Lake Powell

Rule 62 Foundation will not plan or reimburse for your travel to the event location. If you plan on driving, carpooling is a great idea! We're more than happy to try connecting you with other attendees in your area, but there are no guarantees. If you plan on flying, there is a nearby airport in Page, AZ (PGA). Please contact us directly for further details.

Sleeping/Camping Supplies

You will be camping on the lake shore. There will be plenty of space available on a variety of surfaces; including soft sand, pebbles, and flat rocks. You are responsible for bringing sleeping supplies such as a tent, sleeping bag, pillow, blanket, etc. If you cannot access such supplies, we will do our best to help.

Personal Care Supplies

After leaving the dock, what you bring is what you will have. Meaning, there will not be any stores, shops, or markets available after hitting the water. You are responsible for personal care supplies such as a toothbrush, toothpaste, deodorant, soap, shampoo, sunscreen, etc. While other attendees may have extra to share, do not depend on that as an option.

Dietary Restrictions/Preferences

Food and beverage will be provided throughout the week. However, we cannot accommodate all dietary restrictions and/or preferences. If you have strict dietary needs, bring your own food and beverages. As previously stated, once on the lake there will not be access to grocery stores or markets. Meals are not pre-planned and therefore a full menu cannot be provided in advance.

Notice of Withdrawal Deadline - 10 Days Prior to Event

If you are unable to attend the event after registering, you must provide notice at least 10 days prior to the event. Since this is a free event and space is limited, failure to provide sufficient notice of withdrawal will result in a **mandatory \$200 donation to the Rule 62 Foundation**. Emergencies, illnesses, and/or certain unforeseen events may be considered exceptions.

ARRIVAL & DEPARTURE



There is a **\$30 entrance fee** that admits one single, private, non-commercial vehicle and is valid for seven (7) days. Overnight parking is available near the dock. Event attendees are responsible for their own vehicles and associated fees.

Our boats will be leaving the marina dock by **sunrise on Monday, October 7, 2024.** Unfortunately, anyone not present and accounted for will be left behind.

While on the lake, return transportation will be limited to emergencies and/or cases that are requested/approved in advance.

We will be returning to the marina on Thursday, October 10, 2024 by 3pm.

With such an early departure time on Monday, we highly recommend arriving the day before. Our team members will be arriving in Page, AZ on Sunday, October 6, 2024. We host a pre-event dinner and stay at a nearby hotel. For event attendees who want to arrive early, hotel accommodations <u>ARE NOT</u> included as part of this trip. However, we will have a reserved group camping site at the marina which is open and available for anyone to use.
